Thank you for your interest in our professional intelligence collection service. You are receiving this letter in response to your request for a quotation of the various services we perform using Technical Remote Viewing and the related project fees.

The two basic service options you can choose from are:

Our team will collect the intelligence data, sort and analyze it and prepare a comprehensive report especially for you. The fee for this service is fixed and subject to the terms and conditions of this Project Engagement Letter.

- b) A consultation which may be via phone, email or video conference, to establish project and targeting requirements, and/or at least one follow up consultation after the delivery of the final written report to go over data. (Consultation requirements may vary from project to project and require additional fees beyond the standard two visits.)

- c) A formal written report where your data has been documented and analyzed and put into a format you can actualize.
